NOTICE

of force majeure circumstances (force majeure)

As is known, with the decree of the President of Ukraine of 24.02.2022 No. 64/2022 due to the military aggression of the Russian Federation against Ukraine the martial law was imposed on the territory of Ukraine from 05:30 a.m. on February 24, 2022, for 30 days.

The above necessitates that the Contract provisions and the effective legislation on force majeure circumstances and their consequences directly affecting implementation of the Contract are immediately applied to our contractual relationships.

Thus, the force majeure circumstances are extraordinary and unavoidable circumstances that objectively make it impossible for the Parties to fulfill their obligations under the terms of the contract, obligations under legislative and other regulations, namely: war, including undeclared war, threat of war, armed conflict or serious threat of such conflict, including but not limited to hostile attacks, blockades, military embargo, international sanctions, foreign and domestic enemy actions, general military mobilization, military actions, anti-terrorist operations, public enemy actions, riots, acts of terrorism, sabotage, piracy, disorders, invasion, blockade, revolution, revolt, uprising, mass riots, curfew, expropriation, forced takeover, seizure of enterprises, requisition, public demonstration, blockade, strike, accident, illegal actions of third parties, fire, explosions, long breaks in the work of transport, regulated by the terms of the relevant decisions and acts of public authorities, embargo, prohibitions (restrictions) on exports / imports, etc., any other actions of third parties that directly or indirectly make impossible or restrict in whole or in part the economic activity of the Party, insolvency of the Party which occurred as a result of any of the above listed circumstances.

The Party, for which the impossibility to fulfill the obligations occurred, is obliged to notify the other Party in a written form within a reasonable time or within other term stipulated by the relevant Contract and provide the respective documents issued by the authorized state body or the Ukrainian Chamber of Commerce and Industry (through its territorial branches) evidencing the occurrence of the mentioned circumstances.

The term of fulfillment of the obligations under the Contract shall be automatically extended for the period of force majeure, provided that the relevant Party notifies the other Party in a timely manner.

Considering the above and enclosing the Official letter of the Ukrainian Chamber of Commerce and Industry of 28.02.2022 No. 2024/02.0-7.1 to the present Notice,

WE INFORM:

- 1. On the fact of force majeure circumstances (force majeure) throughout the territory of Ukraine from February 24, 2022, until their official ending.
- 2. Please note that these circumstances are extraordinary, unavoidable and objective circumstances for business entities and / or individuals under the contract, a separate tax and / or other obligation / obligation, the fulfillment of which occurred in accordance with the terms of the contract, agreement, legislative or other regulations and the implementation of which became impossible in the set deadline due to the occurrence of such force majeure circumstances (force majeure)
- 3. In the event of prolongation of force majeure circumstances for more than thirty calendar days, Limited Liability Company Fuchs Mastyla Ukraina will take measures to determine the order, grounds and conditions of further fulfillment of its contractual obligations.

At the same time, Limited Liability Company Fuchs Mastyla Ukraina continues to take all necessary actions in order to realize its obligations under the Contract taking into account the conditions of martial law and the realities of today.




